SUBJECT: SVMCA Medication Box Recertification – October 29, 2010

The SVMCA EMS Medication Box Recertification will take place the morning of October 29th, 2010. The following changes will occur:

1. Terbutaline (Brethine) 1 mg/ml will be removed from the boxes. This drug is not currently approved by the State MDCH EMS Section for use in the field. A protocol was submitted to keep it as “post-radio” but it was denied.
2. Diazepam may now be supplied in an “I-Secure” syringe rather than a carpject. Training materials on using the I-Secure syringes has been supplied to all ALS providers.
3. The primary macro drip set may be packaged slightly different. The stock number has changed but the number of ports and function of the tubing is no different.
4. In the future, if Fentanyl is supplied in a glass ampule, there will be a filter straw also supplied. This is to prevent any small shards of glass from being picked up into the lumen of a needle. We hope to minimize any use of glass ampules though and prefer the pre-filled syringes but shortages may dictate how the drug is packaged.

Finally, just a note to everyone: There has been a serious rash of boxes turned into pharmacy with used syringes, needles, and other contaminants. Please respect the next person that must re-stock and use your drug box by ensuring used supplies do not get placed in the EMS drug boxes.
